

- Review the qualifications required for the position and other key qualifications – then apply!
- the requirements and qualifications, a Recruiter will reach out to you for an exploratory conversation and determine next steps
- Interviews can take place virtually or inperson

- 2-3 Rounds:

The PCAOB is a not-for-profit corporation established by Congress to oversee the audits of public companies in order to protect investors and further the public interest in the preparation of informative, accurate, and independent audit reports. The PCAOB also oversees the audits of brokers and dealers.

Our investor protection mission is focused on modernizing audit standards, enhancing audit inspections, and strengthening enforcement of PCAOB rules and standards and other related laws and rules. As we carry out that mission, we strive to uphold the highest standards in audit quality with investors' families, savings, and futures in mind. #### **CAREER OPPORTUNITIES**



The Inspections Specialist will participate in inspections of registered public accounting firms.

The PCAOB has full-time, regular positions for <u>Inspections Specialist</u>.

The Division of Registration and Inspections (DRI) inspects registered public accounting firms in connection with the firm's performance of audits, issuance of audit reports, and related matters involving U.S. companies, other issuers, brokers, and dealers.

#### Qualifications include:

- Current CPA (Certified Public Accountant) and/or CISA (Certified Information Systems Auditor) license required
- Bachelor's degree in Accounting and having attained Manager level at a large accounting and consulting firm
- Six to fifteen years of experience in public accounting, including experience in the audit of companies publicly traded on the U.S. markets

#### **RECRUITMENT PROCESS**

The PCAOB offers a Hybrid Work Option where staff can choose to live and work from anywhere within the United States but will be required to commute to their assigned office or location for occasional intentional gatherings or meetings at the frequency required by their supervisor. Travel to an assigned office or location for commuting purposes will not be considered reimbursable business travel, unless otherwise required by state law.



- Our recruitment process generally involves providing information on previous public company auditing experience and participating in a few panel interviews
- Our Recruiting Managers will serve as advisors and support you by helping you prepare for the interview with best practice tips
